4. Hereby “SECOND PARTY” whose sole responsibility is to manufacture cotton wicks from cotton wick making machine sold to “SECOND PARTY” by the “FIRST PARTY” to which the manufactured cotton wicks would be buyback by the ”FIRST PARTY”
5. As mentioned in the point 4 above “FIRST PARTY” should pay labor charges as 70 Rupees per Kg for wicks making by machine and tail colour for wicks 30 Rupees per Kg depend upon quality of the terms and conditions of this MOU as set forth herein.
